1. **PRIVACY STATEMENT**

- 1.3 We will always comply with relevant data protection legislation (including the Data Protection Act 1998 ("DPA") and General Data Protection Regulation ("GDPR") as applicable) when dealing with your personal data. 2. WHAT INFORMATION DO WE COLLECT AND WHY?

- 2.1 We will only collect personal data to the extent that it is required for the specific purpose made clear to you at the time. We will only process personal data in accordance with relevant data protection legislation.
- 2.2 If you contact us, we will keep a record of that contact including your contact details and any relevant account information.
- 2.3 In addition to your access details, we will log details of your interactions with us including transactions you carry out through the Site.
- 2.4 Like most websites, the Site uses cookies. These are small text files that are sent to your computer when you log into this site. By using a cookie we can keep track of your log-in status even if you leave the site and return.
